TOWN OF CALYPSO, NORTH CAROLINA CEMETERY/BURIAL POLICY ADOPTED AMENDED 1-6-2020

- 1. DEEDS All persons desiring to purchase a plot/lot in the Calypso Cemetery shall apply to the Town Clerk who, upon payment of the fixed price for each plot/lot, shall cause a deed to be issued.
- 2. CEMETERY USE The Town of Calypso prohibits burial of anything other than human remains in the Town Cemetery, and no person shall be interred or disinterred without lawful authority and/or permission being obtained. All graves shall be at least four feet in depth, and all graves shall be dug under the supervision of a Town Representative.
- 3. MONUMENTS AND/OR GRAVE MARKERS All graves shall be marked by a monument or foot marker in accordance with the provisions shown in #4, and must be installed within 90 days after interment. However, before any PERMANENT grave marker of any kind can be placed at the cemetery, a permit shall be obtained from the town at a cost of \$50.00. Headstones and footstones will be placed by appointment only and supervised by Town personnel only. No grave shall be marked with a VAULT LID.
- 4. Only one central or family monument shall be allowed on a family lot. Markers shall be laid flush with the ground, and shall not exceed two feet in length and one foot in width, and shall be placed at the end of the grave farthest from the monument. Any permanent marker or monument will be placed at the expense of the deceased's family or others, and must contain the name of the deceased.
- 5. LANDSCAPING No person shall plant or set any tree, shrub, flower, grass or other plant of any kind in the cemetery. All grading, landscaping and improvements of every kind shall be made or done by the Town of Calypso only.
- 6. STRUCTURES Only granite or marble mausoleums will be permitted to be installed in the cemetery. If at any time any mausoleum, monument or tomb become unsafe, unsightly, or in need of repair or resetting, The Town shall notify the owner of the lot, or any person having an interest in the lot, and shall request the person to make the needed repairs under his/her supervision, and if the person fails to make the repairs within 30 days, the Town Council may order the repairs to be made, or remove the same from the lot as the Town Council may elect.
- 7. TRANSFER OF PLOTS Any sale or transfer of Plots/Lots must be reported to the Town Clerk.
- 8. CLEANLINESS All materials carried within the cemetery and not used in the erection of monuments or markers will be promptly removed by the owner of the plot/lot. The family of the deceased is responsible for the removal of old, soiled, and/or dead floral arrangements from graves. However, the Town reserves the right to remove old, soiled, and/or dead floral arrangements from graves if the family fails to do so after 10 days.
- 9. GENERAL REGULATIONS All plots/lots within the Calypso Cemetery, and within any extension of the cemetery at any time hereafter made, whether owned by the Town of Calypso or by any other person or persons, shall be subject to and regulated and controlled by the provisions of this chapter; and in all deeds of conveyance by the Town of Calypso to any person or persons for any lot, the following provisions shall be included therein as a covenant running with the land: "This conveyance is made subject to an ordinance adopting rules and regulations for the control of Calypso Cemetery and providing penalties in relation thereto duly of record of the minutes of the proceedings of the Town council of the Town of Calypso, and the grantee herein, his or her heirs and assigns, agree that upon the breach of any of its provisions, the title to the property shall fever to the Town of Calypso."
